Dear Chairmen Diaz-Balart and Coons and Ranking Members Lee and Graham:

On behalf of the undersigned 96 international exchange organizations, business associations, and chambers of commerce, we write to express our strong support for the Department of State's BridgeUSA exchange programs (formerly the J-1 Exchange Visitor Program). Specifically, we support including previously enacted appropriation provisions in the FY25 State, Foreign Operations, and Related Programs Appropriations package. These provisions reiterate that any regulatory changes made by the executive branch to BridgeUSA exchange programs must be done pursuant to the congressional requirements of formal rulemaking specified in the Administrative Procedure Act.

We also express our support for the Department of State's federally funded exchange programs and ask that the Subcommittee fund educational and cultural exchange programs at \$808.6 million in FY25.

BridgeUSA exchange programs were established by the Mutual Educational and Cultural Exchange Act of 1961 (the Fulbright-Hays Act) and are administered by the Bureau of Educational and Cultural Affairs (ECA) within the Department of State. They include such programs as the Au Pair, Camp Counselor, High School, Intern, Summer Work Travel, Teacher, and Trainee categories, among others. These programs provide invaluable cross-cultural experiences for young people from abroad and the Americans they interact with during their programs. They are also vital to the economic, public diplomacy, and foreign policy interests of the United States at virtually no cost to the American taxpayer. BridgeUSA programs expand our international outreach by making an American exchange experience accessible to thousands of international students and young professionals who could not otherwise afford to visit or study in the U.S.

BridgeUSA is a diverse collection of exchange programs established by Congress. Any executive branch modifications to the programs should follow transparent processes pursuant to rulemaking under the Administrative Procedures Act and congressional oversight. This important provision has been included for the past six years in the State and Foreign Operations Act of the Appropriations bills.¹

We ask that the following proposed language be included in the FY25 State, Foreign Operations, and Related Programs bill:

EXCHANGE VISITOR PROGRAM.—None of the funds made available by this Act may be used to modify the Exchange Visitor Program administered by the Department of State to implement the Mutual Educational and Cultural Exchange Act of 1961 (Public Law 87–256; 22 U.S.C. 2451 et seq.), except through the formal rulemaking process pursuant to the Administrative Procedure Act (5 U.S.C. 551 et seq.) and notwithstanding the exceptions to such rulemaking process in such Act: Provided, That funds made available for such purpose shall only be made available after consultation with, and subject to the regular notification procedures of, the Committees on Appropriations, regarding how any proposed modification would affect the public diplomacy goals of, and the estimated economic impact on, the United States: Provided further, That such consultation shall take place not later than 30 days prior to the publication in the Federal Register of any regulatory action modifying the Exchange Visitor Program.

In an ordinary year, BridgeUSA programs contribute more than \$1.2 billion to the U.S. economy, according to a series of studies by the independent research firm EurekaFacts². The programs support jobs for Americans in nearly every state and in many sectors of the U.S. economy. Specifically, exchange program participants contribute to seasonal businesses and communities by filling job vacancies that would otherwise go unmet. More importantly, the exchange visitors employed by the local businesses in these communities are necessary to keep year-round American workers employed in their jobs. Exchange visitors also provide crucial childcare to more than 20,000 American families – including hundreds of military families and families of medical personnel who would not be able to serve our country and their local communities without the support of these programs.

According to the EurekaFacts studies, Summer Work Travel participants contributed \$5,300 per person to the U.S. economy in 2017, for a total of \$509 million. Au pairs contributed \$5,336 per person per year to the economy, for a total of \$257 million. Additionally, Camp Counselor participants contributed \$59.1 million, and Interns/Trainees contributed \$662.6 million.

Exchange programs broadly advance U.S. national interests in enhancing mutual understanding between the U.S. and people from other countries. For example, according to the EurekaFacts studies, more than 75% of Summer Work Travel exchange visitors returned to their home countries with a more positive opinion of the United States, and 88% of Au Pairs better understood the American values of freedom and independence. 75% of Intern and Trainee participants developed a more positive view of Americans, and 85% of Camp Counselors developed a more positive view of American culture.
